

## INVITATION FOR BIDS

### Central Miner St and Soda Creek Road Improvements

Issuing Agency: City of Idaho Springs, Colorado

The City of Idaho Springs, Colorado, hereby solicits bids for Central Miner Street and Soda Creek Road Improvements. Sealed bids will be accepted until 2:00 p.m. Mountain Standard Time on October 9<sup>th</sup>, 2018, at which time all bids will be publically opened and read aloud. The low bidder will be validated and the awarded bidder will contract with the City to perform the work. The scope of work includes reconstruction of 0.25 Miles of Miner St and 0.4 Miles of Soda Creek Rd including utilities, curb & gutter, sidewalks, miner pedestrian bridges, aggregate base and asphalt paving. There are two plan sets, one for Central Miner St Improvement and one for Soda Creek Road Improvements, and one set of project special provisions. This contract will require construction of both plan sets as a single construction contract.

#### **Project Description:**

The project consists of reconstruction of storm drain, sanitary sewer, water main, pedestrian bridges, curb & gutter, sidewalks, and asphalt paving for 0.25 miles of Miner St between Riverside Drive and Colorado Blvd and 0.40 miles of Soda Creek Road south from Miner St.

**Prequalification Requirement:**

Bidders shall be prequalified with the Colorado Department of Transportation (CDOT) at the \$5-20 million level at the time of submitting a bid. Contact CDOT directly at <https://www.codot.gov/business/bidding/prequalification-application/view> to become prequalified. The low bidder will be checked against CDOT's prequalification list to verify the bidder is prequalified in good standing with CDOT prior to award.

**Mandatory Pre-bid Meeting:**

A mandatory Pre-bid Meeting will be held from 2:00-4:00 p.m. Mountain Standard Time on September 25, 2018 at the Idaho Springs City Hall, 1711 Miner Street, Idaho Springs, CO.

**Job Showings:**

All prospective bidders are encouraged to schedule an optional job showing with the Project Manager. Refer to the project specifications for more information.

**Questions Shall Be Submitted in Writing:**

All questions regarding the plans, specifications, contract, and bidding process are due in writing by 5:00 p.m. Mountain Standard Time on October 1, 2018. Written responses will be provided to all plan holders by 5:00p.m. on October 5, 2018 in accordance with the provisions of the Notice to Bidders in the specifications.

**Bid Proposal Guarantee:**

All bidders shall submit with their Bid Proposal a Bid Proposal Guarantee in the form of a certified check, cashier's check, or bid bond in the amount of 5 percent of the Contractor's total bid.

**Bid Proposal Elements:**

A complete Bid Proposal consists of the following information. Failure to submit any of these documents will result in rejecting the bid.

1. Bid Proposal Form. All required cells completed, total bid amount written in numbers and words, and signed by authorized representative of the firm
2. Bid Proposal Guarantee
3. Anti-Collusion Affidavit
4. Current CDOT Prequalification Certificate at the \$5-20 million level
5. Certificate of Good Standing issued by the Colorado Secretary of State

The Low Apparent Bidder's documents shall be verified by the Program Manager as a prerequisite of award.

**Construction Completion Date:**

The contract will be based on a completion-date specification. Construction shall be complete by the date in the specifications, currently set for September 27, 2018.
